Vide notification no.  4. Caste Certificate (EWS/SC/ST/OBC-NCL/ Supernumerary) as per rules
 5. Certificate for Physically Challenged persons
 6. Certificate for NSS/ NCC/ Sports/ Supernumerary / Ex Serviceman/ Kashmir Migrant etc.
 7. School Leaving Certificate and Character certificate from the last school attended (To be submitted in original)
 8. 2 passport size photographs with clear background (SELFIE photographs are not allowed)
 9. Anti-ragging Declaration (students have to fill online undertaking and also submit Anti-Ragging compliance form on www.antiragging.in)
 10. Document showing ABC Id as generated through DIGILOCKER
- In case of failing to submit the above required documents, the candidature of the applicants shall be cancelled and shall not be allowed to take admission into the programme.
- In no circumstances, the date of admission will not be changed or extended.
