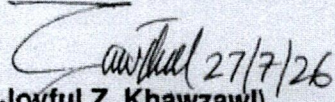
Sub: Circulation of directions in pursuance of the meeting held on 24.07.2026 under the chairmanship of the AS (Edu.)-reg.

Sir / Madam,

I am directed to refer to the discussions held during the meeting held on 24.07.2026 under the chairmanship of the AS (Edu.) and to request all the Central Universities under the administrative purview of this Desk for adherence to the following directives:

- i. Universities shall ensure the comprehensive implementation of all forty (40) modules of the *SAMARTH* portal.
 - ii. All scholarship schemes and programmes must be prominently displayed and duly notified on the Notice Board of the University's official website.
 - iii. The provisions envisaged under the *National Education Policy, 2020* pertaining to *APAAR ID* and *ABC ID* shall be strictly adhered to.
 - iv. Universities are advised to convey the contact details of a *Nodal Officer* to ensure prompt responses to correspondence received from VIPs, the PMO, and other authorities.
 - v. Universities shall comply with the prescribed timelines for submission of their *Annual Financial Statements* and *Annual Reports* to the Ministry, so that these may be laid before both Houses of Parliament in a timely manner.
2. The Universities are also requested to furnish the following information:
- i. The date of start of current academic session of the University after the summer vacation.
 - ii. The total enrollment/intake of students in the University.
3. Further, all the Universities are also requested to furnish their official social media handles like X (formerly Twitter), Facebook, Instagram etc., if any, to this Ministry.
4. This may be treated as **urgent**.
